

St. Vital Centre's Behind Closed Doors Contest Rules and Regulations

1. ELIGIBILITY: This contest runs October 1, 2017, 8:00am (CST) to November 18, 2017, 10:30pm (CST). Entrants must be residents of Manitoba. All early entries including non-event entries must be completed and returned to the St. Vital Centre Customer Service Booth by November 18, 2017 by 6:00pm. Altered ballots or incomplete ballots will be disqualified. Any entrant who does not comply with these Rules and Regulations for this contest will be disqualified.
