1. **CONTEST PERIOD:** The “Pop-up Your Shop” contest (“**contest**”) begins on March 12, 2019, 6:00am PT and ends on April 15, 2019, 5:59pm PT, (“**Contest Period**”).
2. **ELIGIBILITY TO ENTER:** The contest is open to legal residents of Canada at or over the age of majority. Employees, principals, representatives or agents of TBC Nominee Inc., The Manufacturers Life Insurance Company, Cushman & Wakefield Asset Services ULC (collectively, the “**Contest Sponsors**”); and immediate families (spouse, mother, father, sister, brother, daughter or son, regardless of where they live) or members of their same households (whether related or not) of any of the Contest Sponsors are not eligible to enter.
3. **HOW TO ENTER:** Commencing March 12, 2019, business owners are invited to submit their completed Application Form and a copy of their Business Plan to be entered for their chance to win one of three prizes.

Agree to Terms & Conditions

CONSENT & RELEASE

For the purpose of this Agreement, "Business Proposal" means, as applicable, any and all information, data, methods, ideas, presentations, and strategies, whether copyrighted, trademarked, or not, relating to the business idea proposed, including but not limited to the business plans, the products and/or services the business provides, the prototype and the models.

I understand that I am being considered as a contestant for the Contest and will be judged based on my submission by a panel of selected judges.

By signing this Consent and Release (the "Agreement"), I represent that I have read, understood and voluntarily agree to abide by its terms and conditions. The Contest Sponsors require me to enter into this Agreement in order to be considered as a contestant in the Contest, and I deem it to be in my best interest to enter into this Agreement.

I acknowledge that by signing this Agreement, I will be giving up certain legal rights I may have against the Contest Sponsors and others.

In consideration of being considered for and possibly selected to participate in the Contest (notwithstanding whether or not I am selected as a contestant for the Contest and for other goods and valuable consideration which I have received, I hereby represent and warrant that the following statements are true and correct and that I irrevocably agree to the terms and conditions contained herein:

1. I have provided my Business Proposal and have answered the questions in the foregoing Application I truthfully, accurately and completely, and will immediately inform the Contest Sponsors if any information I have provided changes, is discovered by me to be false, inaccurate or incomplete or becomes false or incomplete. I acknowledge and agree that, except as expressly stated in this Agreement, there is no agreement between the Contest Sponsors and myself, express or implied, relating to the Business Proposal, my submission of the Business Proposal to the Contest Sponsors and/or the Contest Sponsors' acceptance of the submission or the Business Proposal, and no promises or representations have been made to me to induce me to enter into this Agreement and/or to submit the Business Proposal.
16. 17. I acknowledge that the Business Proposal will be reviewed under guidelines set at the Contest Sponsors' discretion and that I will be notified if there is interest in the Business Proposal. If there is no interest in using the Business Proposal in connection with the Contest, the Contest Sponsors are not obligated to offer an explanation and has no further obligation to me whatsoever.
18. I acknowledge and agree that it is my own responsibility to ensure that all of my rights in the Business Proposal and otherwise have been properly secured and will not be prejudiced through my participation in the Contest, and that any disclosures made by me relating to myself or the Business Proposal will comply with all applicable legislation, including any securities law.
19. 21. I acknowledge, agree and understand that, separate and apart from the Contest, the Contest Sponsors, and other contenders are currently in the process of designing new products, developing new business plans and methods for conducting business, etc., and I agree that I will not at any time seek legal remedies against any of the above mentioned entities for their development, acquisition, manufacture or distribution of any product/service/method similar or identical to that of the Business Proposal. I agree to impose the provisions of this paragraph on any third party to whom I may assign the Business Proposal.
22. If I display any photographs, published works, and/or other artistic materials, which are not registered with a performance rights society, then I will have obtained all of the rights, clearances and releases necessary for the Contest Sponsors to exploit said materials on or in connection with the Contest and the exploitation thereof and that all such photographs, published works and/or other artistic materials shall meet nationwide public standards of decency and shall not be deemed inappropriate by a reasonable person. I agree to indemnify the Released Parties and to hold the Released Parties harmless from any and all liability, claim, action, damage, expense, and loss of any kind caused by or arising out of any statement, action or failure to act by me during or in connection with my participation in the Contest and the selection process therefore.
25. No breach of this Agreement shall entitle me to terminate or rescind the rights granted to the Contest Sponsors herein. I hereby waive the right, in the event of any such breach by the Contest Sponsors, to equitable relief or to enjoin, restrain or interfere with the exercise of any of the granted rights, it being my understanding that my sole remedy shall be the right to recover monetary damages with respect to any such breach.
26.
